

3. 本校只接受網上報名申請，逾期申請恕不受理。
4. 在指定日期內之申請者，本校均會安排約見。
5. 請確定齊備所有文件才進入網上報名系統，如有文件或資料缺欠將不能完成報名程序。
6. 家長完成所有報名程序後，系統及Paypal會自動發出確認申請電郵及確認付款電郵。

**Please prepare electronic files of the following documents for online application upload:**

- (1) Recent photograph of the applicant
- (2) Applicant's birth certificate
- (3) Certificate of Entitlement (for those children not born in Hong Kong)
- (4) Student's information of the applicant's sister(s) who currently studying in our secondary school, elementary school or kindergarten, e.g., student's personal information from the student's handbook or the student identity card. (If applicable)
- (5) Graduate certificate of the applicant's sister(s) if sister(s) previously attended in our secondary school or elementary school. (If applicable)
- (6) Graduate certificate of the applicant's mother as an alumnus of our school (If applicable)

**Application fee:** HK \$40 (It will go straight to the PayPal payment page when you complete filling out the application form. Parents can pay the fee if you have your PayPal account or credit card.)

**Remarks:**

1. The school-based admission mechanism must be fair, just and open, and to ensure that the conditions of admission meet the existing ordinances and equal opportunities ordinance. The professional education, home-school cooperation, child's well-being, care for children and other aspects are included in the considerations of setting the school-based admission criteria.
2. When interviewing NCS children, translation service for applicants could be arranged where necessary, or parents and children are allowed to be accompanied by a Chinese speaking relative/friend to facilitate communication.
3. The School only accepts the online applications. Late applications will not be accepted.
4. The interviews will be arranged for the applicants who applied within the specified dates.
5. Make sure you have all the documents ready to upload before entering the online application system. If there is any missing document or information, the application procedure will not be completed.
6. System and the PayPal will automatically send the confirmation email for your application and your payment receipt after parents successfully complete the whole application procedure.
7. The application fee will not be refunded once it is paid.
8. The School will inform parents of the application procedure by email. If the parent fails to receive the email from us within the specified time, please check the "junk mail / trash". Please contact us in case you still fail to receive it.
9. For those children who have not been admitted, parents can follow the methods announced on 16th December, send your child's information via email to the specific email address, and to apply the applicant on the waiting list. The school will notify the parents by phone call and arrange the interview to the applicants on the waiting list once there is a vacant school place. Late applications will not be accepted.
